Parent Commitment Form

I would like to enroll my child in the K-5 Dual Language Spanish Immersion program. I understand that:

- I will receive notification from the school indicating the status of my child's application and that submission of this form does not ensure enrollment to the K-5 DL/I program.
- Long-term participation of 5 to 7 years is required for the benefits of the program to be fully realized based on findings from Thomas & Collier longitudinal studies. Thus, enrolling my child in the K-5 DL/I program is a long-term commitment.
- Teachers will work towards helping my child become bilingual and biliterate, as well as develop cross-cultural skills and experience success academically.
- Learning a second language takes time and it is not unusual for a child to experience some fatigue or frustration during the initial stages. I will keep my child in the program unless consideration of reassignment to a regular classroom is recommended by a teacher, principal, and/or other educational experts.
- I may not always be able to help my child do homework or read in the second language; it is ok for me to provide support in the language spoken at home.
- I will engage in reading with my child on a regular basis in his/her home language several times a week to support the development of literacy skills.
- Students in the K-5 DL/I program will remain together for their entire elementary career (K-5). School administration will provide my child opportunities to interact with other children through various activities.
- Dual language students whose families are requesting Discretionary Admission and Release (DAR) must attend Enrollment Day at the child's home assigned school.
- Employees of Buncombe County Schools wishing to enroll their child(ren) in the DL/I Program will participate in the lottery.
